- Use of MCC private swimming pool during designated pool hours Memorial Day through Labor Day
- Use of snack bar and pool-side or patio dining Memorial Day through Labor Day
- Ability to bring guests to the MCC pool *guests must be signed in and a \$4 fee will be applied to membership charge unless paid by guests

Summer Pool Membership Rules/Regulations:

- Applicant is personally responsible for family members and guests at all times – LIFEGUARD NOT ON DUTY
- Applicant must provide a credit card to be safely and securely held by the club's office. All charges will be automatically charged to the provided card the 21st or 22nd of each month. If a card fails to work properly or to accept accrued charges, the pool member will have 1 week to provide a new card number before pool membership privileges are revoked – NO REFUNDS. Accrued charges must be paid by an alternative method within 30 days.

Swim Membership Fees & Payment Options:

- Option A) \$550 + tax paid in full by check, cash, or credit card before membership can begin
- Option B) \$275 + tax paid when application is turned in check, cash, or credit card with the remaining balance of \$275 + tax charged automatically to provided credit card June 30th. If provided card fails to work properly or to accept this charge, the applicant will have 1 week to provide a new card number before the swim membership is revoked – NO REFUNDS
- Option C) Plan Ahead for next year! \$110 + tax charged automatically to provided credit card the 15th of each month January through May. If provided card fails to work properly or to accept these charges, the applicant will have 1 week to provide a new card number before the application process is terminated – NO REFUNDS
